Hort Line: Patti Kolek | A training session for Hortline volunteers is scheduled for April 1, 2025 at 10:00 a.m. in Conference Room B. Hortline in-office hours at the Extension office have resumed. Patti shared Judy Klemme's experience as a Hortline volunteer. Judy recommended the Hortline volunteer experience, commending the learning resources available to research questions, support of the Hortline leadership and personal fulfillment that comes with helping Hortline callers.

Farmers Markets: Patti Kolek | St. Charles Master Gardener Association will be represented at the Riverwalk St. Charles Market on Saturdays beginning May 1 through September. Representatives will attend the St. Charles Senior Expo on Friday, April 4 and the Weldon Springs Plant Expo on May 17.

Upcoming Speakers: Val Mertz | Rosanne LeBaige will present a program on the *Impact of Light Pollution* at the April 24, 2025 membership meeting. The June meeting speaker will be Nicholas Krekler. The program topic is *Landscaping the Arch Grounds* and he will explain his work as general manager, landscaping and planting the Arch grounds with Site Systems. The intricate project includes bioremediation of the soil and hand-picked specimens. Phebe Martin mentioned that Nicholas is also an expert on mushrooms, orchids and rare house plants.

Donna Lindsey thanked everyone who helped with seeding, transplanting, growing and watering the pansies, onions,

lettuce and other cool season crops. The Cool Season Plant Sale made \$3,316.25. The total for the 2024 sale was \$2,837. Bill and Dee Rhinesmith made cedar planting boxes that were very popular at the sale.

A seeding and transplanting party (tomatoes, some annuals and some transplanting) will be held Saturday, March 29, from 10:00 a.m. – 3:00 p.m. Next parties are scheduled for 10:00 a.m. on Saturday, April 5 (transplanting peppers); Wednesday, April 9 (transplanting tomatoes); Wednesday, April 16.

A Pre-Sale on Saturday, April 19 from 9:00 a.m. – noon will be held for Master Gardeners, their immediate families (who must be accompanied by their Master Gardener), Extension staff and Council members. Set-up for the Pre-Sale is on Friday, April 18 from 9:00 a.m.-noon and 1:30 p.m.-4:00 p.m. Signup Genius will be in the Monday Blooms so that you can sign up for particular set-up shifts. For the sale, bring your own boxes (extra boxes are not needed this year due to a donation received) and please consider paying by cash or check to alleviate the charge for processing transactions.

The Public Sale will be held on Saturday, April 26. Shoppers will need to use Signup Genius to reserve shopping times for 9:00-10:00, 10:30-11:30, 12:00-1:00 and 1:30-2:30. These reservations are required because parking is limited to 50 parking spots. Master Gardeners who cannot attend the Pre-Sale may come to the Public Sale but a reservation is required.

Signup Genius will be available for Master Gardeners to volunteer for set-up on Friday, 4/25; work the sale on Saturday, 4/26; and work the sale and take down on Sunday, 4/27. On Saturday, Master Gardeners should park in the ballfield lot to the east of the Extension office on Brown Road. Shuttle drivers will be available. Volunteers should wear a Master Gardener T-shirt. A group picture will be taken at 8:15 a.m. on Saturday. More information will be in the *Monday Blooms* newsletter.

Demo Gardens: Cindy Platzer, Bekah Davis | Bekah reported that Wednesday and Saturday workdays would officially open the first week in April. All volunteers can expect to find garden lead teams present on the official workdays to guide volunteer participation in the various gardens. Volunteers are needed for the lawn push mower team managed by Kevin Minard and new leads are being sought for the Lasagna Garden and the Turf areas. Earl Ahart has developed a Fairy Garden which is situated at the entrance to the large conference room. Leaf mulch has been ordered. Wood chips will be evaluated for state of decomposition and may need to be ordered. Galvanized steel beds have been installed in the Pantry Garden. Garden leads who are interested in obtaining unused material from the project including rounded ends to construct small round beds should contact Phebe Martin.

Old Business: The liability insurance issue has been resolved with coverage obtained for one year. The MU Extension will provide new directions for the Master Gardener Association and the Steering Committee will re-address insurance needs in December.
